“A Conversation with General Suter: Stories from the U.S. Supreme Court”
Speaker: General William Suter

General William Kent Suter, the 19th Clerk of the United States Supreme Court, will reflect on the Supreme Court Justices and landmark cases that marked his 22 years of service to the Court.

General William Kent Suter was the 19th Clerk of the United States Supreme Court, serving with distinction from 1991 to 2013. His responsibilities included managing the Supreme Court's docket and calendar and overseeing the Supreme Court Bar. He also attended all oral arguments before the Court.

Chief Justice of the United States William Rehnquist hand-selected General Suter for the Clerk position when Supreme Court Clerk Joseph F. Spaniol, Jr. announced his plans to retire at the end of 1990. Before taking that position, General Suter was an Army Judge Advocate, retiring with the rank of Major General. While in the Army, he served in numerous positions around the world, including, Appellate Judge, Deputy Staff Judge Advocate of the U.S. Army in Vietnam, Staff Judge Advocate of the 101st Airborne Division, Commandant of the JAG school, and the Assistant Judge Advocate General of the Army. His military awards include the Distinguished Service Medal, the Bronze Star Medal, and the Parachutist Badge.

General Suter is a graduate of Trinity University in San Antonio, Texas, and the Tulane University Law School. He attended Trinity on a basketball scholarship (experience that would serve him well when he played basketball with law clerks on the "highest court in the land") and Tulane on an academic scholarship. He was on the Tulane Law Review and was elected to the Order of the Coif. He is a graduate of the Judge Advocate General's School Graduate Course, the Command and General Staff College, and the Industrial College of the Armed Forces.

General Suter is a prolific speaker about the Court. A popular figure in the national bar, he has received numerous honors for his frequent outreach efforts, including honorary degrees. He has been a leader among retired judge advocates and a mentor to hundreds of lawyers. At General Suter's retirement celebration on June 12, 2013, Chief Justice John Roberts praised the General's "inspirational leadership" and "good will and friendship" that "have reached all corners of the building and beyond." The Chief Justice noted that General Suter regularly met with school children, law students, and foreign dignitaries, greeting "them all with equal ease and grace, demonstrating both his good humor and his humanity." Chief Justice Roberts also extolled General Suter as having "managed the Court's docket with unparalleled organization and efficiency," "contributions to this Court [that] will not fade away."
